## **Eligibility**

All work must be totally conceived and recently executed by the artist and not previously shown at any WAL show. Each artist may enter two pieces of work.

Mediums accepted are Oil/Acrylic, Pastel, Watercolor, Graphics/Mixed Media, including collage.

**No photography, sculpture, computer graphics or prints are eligible for this show.**

Entries need not be for sale (NFS). Sale price must include frame. Portraits may show price for similar work (SIM).

Art work must be ready for hanging with screw eyes or hangers and wire; the wire not to extend above the top of the frame. No sawtooth hangers will be accepted and mats and frames, if applicable, must be in very good condition. Art work, including frame, must not exceed 44 inches in any direction.

**Entry forms must be attached, properly filled out, to top left corner of back of frame.**

**Artists will be notified if work is not accepted.**

**Carol Reeves** – Carol Reeves is an accomplished and internationally known oil painter with studios in Connecticut and Maine. She has exhibited her work nationally and has been honored with many prestigious awards: The Salmagundi Club, Catherine Lorillard Wolfe, National Arts Club, NYC, Chicago Windy City Artists, Ort Technical Institute, Chicago, Oklahoma Artists, Tulsa, North Light Art Publications National Competition, Pastel Society of North Florida, Academic Artists Assoc., Springfield, MA, New Britain Museum of Art, Renaissance in Pastels, Paul Mellon Art Center, CT, and many more.

**Robert Noreika** – Bob Noreika is a prominent painter and illustrator whose paintings hang in both corporate and private collections throughout the United States, Europe and Japan. He was featured in Artists' Magazine in April, 1998, for his technical expertise. A member of the Connecticut Watercolor Society and the Salmagundi Club, NYC, he received a first award in the New England Watercolor Society's regional show, Attleboro Museum, as well as the Salmagundi Show, NYC, and the New Haven Paint and Clay Club. He was recently awarded Best in Show at the Kent Presidential Show and again at the Kent Fall Show, the award for Oil/Acrylic. He also won first place in watercolor at the Glastonbury fall show.

**Elizabeth Rhoades** - Elizabeth Rhoades is an award-winning pastelist and a Signature Member of the Connecticut Pastel Society, the Pastel Society of America, the President of the Connecticut Plein Air Painters Society, an elected member of the Lyme Art Association, and a member of CT Women Artists, the Pastel Society of the West Coast, Academic Artists Association, and the Pastel Society of New Mexico.
